

International Dentist Program Estimated Expenses 2024 - 2025

The University at Buffalo School of Dental Medicine offers the International Dentist Program (IDP) for the internationally trained dentist who seeks to practice dentistry in the United States.

The IDP program is two years in duration, beginning in May with an intensive preparatory summer course, directly followed by third and fourth years of the DDS Program.

International Dentist Program participants who plan to apply for loans to fund participation in the International Dentist Program must be aware that you will need to apply for **3 SEPARATE loans** (One for the Summer semester and one for each academic year).

This is necessary because loans for the the Continuing Education Summer Program will be certified by the School of Dental Medicine Continuing Dental Education Office (CDE), whereas the loans for the standard tuition and fees you will pay for the Fall/Spring semesters during the two academic years of the program will be certified if you apply and qualify for them, by the University at Buffalo Financial Aid Office.
